## COKE INVITATIONAL TEAMS

### CONTEST RULES

- 1) All competitors must be a member of the surfboard club.
- 2) Team to consist of a maximum of four OPEN division surfers and a manager.
- 3) Team to select only three competitors to surf each round.
- 4) Each competitor allowed maximum two waves and both waves will be scored with second wave being the Power wave (awarded double points)
- 5) Only one member per team to surf at a time
- 6) After the start of each heat each team member must tag each other in official area before entering surf
- 7) Heat Time – 30 mins (depending on conditions heat times can change)
- 8) If a team completes their heat prior to final siren, they will be awarded bonus points.
  - First team to finish under time will receive 6 bonus points
  - Second team to finish under time will receive 5 bonus points
  - Third team to finish under time will receive 4 bonus points
  - Fourth team to finish under time will receive 3 bonus points
- 9) The Head Judges decision is final.  
Depending on conditions heat time can change, check with contest director
